*Fairtrade Advisory Committee members will note that this Act sets out the requirement for a public body to act in a manner which seeks to ensure **that the needs of the present are met without compromising the ability of future generations to meet their own needs.***

In order to act in that manner, a public body must take account of the following things:

- (a) the importance of balancing short term needs with the need to safeguard the ability to meet long term needs, especially where things done to meet short term needs may have detrimental long term effect;*
- (b) the need to take an integrated approach, by considering how—*
 - i. the body's well-being objectives may impact upon each of the well-being goals;*
 - ii. the body's well-being objectives impact upon each other or upon other public bodies' objectives, in particular where steps taken by the body may contribute to meeting one objective but may be detrimental to meeting another;*
- (c) the importance of involving other persons with an interest in achieving the well-being goals and of ensuring those persons reflect the diversity of the population of the part of Wales in relation to which the body exercises functions;*
- (d) how acting in collaboration with any other person (or how different parts of the body acting together) could assist the body to meet its well-being objectives, or assist another body to meet its objectives;*
- (e) how deploying resources to prevent problems occurring or getting worse may contribute to meeting the body's well-being objectives, or another body's objectives.*

118. FAIRTRADE STATUS RENEWAL UPDATE

Members were provided with an update regarding the renewal deadline for Fairtrade status for the town of Barry.

Members were informed that on the 20 May 2021, the Council received email correspondence from the Fairtrade Communications Team. The email advised that they understood that since the beginning of the pandemic local campaigning had been affected in different ways across the country.

In recognition of this, they provided all groups due to renew this year with a further one-year extension. This had been applied automatically and members were to note that the new renewal date was 20 September 2022.

RESOLVED that members note the date to renew Fairtrade Town Status is now 20 September 2022.

119. TO RECEIVE AN UPDATE FROM FAIRTRADE WALES

Members were provided with an update from Aileen Burmeister of Fair Trade Wales, as follows:-

- The Fairtrade Foundation are currently working on their plans for Climate Campaigning this year running up to the COP Climate Conference in Glasgow in the Autumn, The first of these actions is a coalition action

making a “wave of hope” for the G7 next month. More opportunities for campaigning will be coming up over the summer and autumn.

- Fair Trade Wales will continue to hold quarterly meetings for groups. Dates for summer and autumn still to be decided. In the autumn we will be joined by the Communities Campaign Manager from the Foundation to discuss their new ideas for changes to Fairtrade status. They would like feedback on them.
- Fair Trade Wales has got renewed funding for April 2021 – March 2024, so are still available to provide support and are still homeworking.
- Fair Trade Wales is releasing a new website.

The Chair noted that he would forward the correspondence he had received from Fair Trade Wales to all members.

FAIRTRADE ACTIVITIES 2021 - 2022**Report Author**

Purpose of Report

To present members with information regarding activities that have been taking place since the last meeting of the Committee on (2 June) and any activities planned up to 2022.

Background Information**June 2021 – Letters to Ministers**

In June 2021, letters to Assembly Members: Rhys Ab Owen, Jane Hutt, Heledd Fychan, Andrew RT Davies, Alun Cairns and Joel James were written to address concerns regarding the proposals that the UK Government would reduce the proportion of GNI that will be allocated to international aid, and requesting that Government maintain the 0.7% GNI commitment that was set out in the 2015 International Development Act.

August 2021 – Fairtrade Virtual 5k

During August, BTC hosted a virtual 'Fairtrade 5k' where individuals could challenge themselves to run or walk 5km during the month of August and send a screenshot of their fitness app and submit it to BTC as proof. Individuals would then receive a medal and certificate for participating. There was an entry fee of £5 for adults (under 16s were free) and any profits were donated to the Mayor's chosen charities (RNLI and The Vale Food Bank).

December 2021 – Santa Fun Run

Currently, the Santa Fun Run is able to go ahead (Covid restrictions allowing) in December and, as with previous races, the BTC team will be promoting Fairtrade products and giving out bananas.

7 February 2022 – Fairtrade Advisory Committee

AM Jane Hutt has been invited to attend a meeting of the Fairtrade Committee to be held on 7 February 2022. As portfolio holder for Fairtrade Wales and as Social Justice Minister, we are lucky that she will be joining us to discuss WG's Fairtrade Ambitions goings forwards and answer any questions members may have. Members may wish to consider changing the date of this meeting however as mentioned in a previous report.

Fairtrade Fortnight (21 February 2022 – 6 March 2022)

There are plans to hold a social media take-over, promoting Fairtrade and Fairtrade products over the two weeks. Shrove Tuesday falls on 1 March 2022, with the potential

to further promote Fairtrade products for use during Pancake Day. We will also be hosting a Quiz night at the Cemetery Approach Community Centre during the two week period.

International Women's Day

Fairtrade Fortnight is taking place Monday 21st February to Sunday 6 March 2022, with international women's day scheduled for Tuesday 8 March 2022, so there is also scope to organise a coffee morning using Fairtrade tea, Coffee, sugar and biscuits to mark the day and engage with Barry residents about the importance of Fairtrade products.

Mayor on the Square

We will be developing information leaflets for distribution during the monthly 'Mayor on the Square' events.

Current event restrictions as of 26 May 2021 are that organised outdoor activities can have a maximum of 50 participants, and a maximum of 30 indoors.

It should also be noted that the current available budget 2021/2022 is £1,000.

- International Women’s Day 2019 – held coffee morning using Fairtrade Tea, Coffee & Sugar (8 March 2019)
- Held a Fairtrade Tasting Stand at Waitrose, Barry on 21 March 2019
- Held a Fairtrade Roses Valentine’s Day Competition (2019)
- Fairtrade products used at the Mother’s Day Candlelight Service at Merthyr Dyfan Chapel
- Created and Fairtrade Annual Report (2019) showing how the Committee links to the well-being goals.
- Community Engagement Officer attended One Voice Wales conference with Aileen from Fairtrade Wales to deliver a presentation and to encourage more Town & Community Council’s to gain Fairtrade status.
- 23 Sept 2019 – Morrisons Supermarket Community Champion attended a meeting to discuss how the group and supermarket could work together better
- Halloween 2019 – The Dark Side of Chocolate Social media campaign

- November 2019 – Local community learning charity, ValePlus, joined the Fairtrade Group as a member

- Fairtrade Hamper – Christmas Competition in which participants had to say why they used Fairtrade products.

2020

- Vale Plus hosted Fairtrade Cream Tea Events at their Café No.5 venue, with a small grant to purchase Fairtrade Tea, Coffee, Sugar and ingredients. Jenipher, a Fairtrade coffee producer from Uganda, attended an event there on 27th February 2020.

- Cllr Johnson gave a presentation on Fairtrade to Year 6 pupils at Ysgol Sant Baruc. Jenipher also attended the school at a later date to talk with pupils about the experiences of a Fairtrade coffee farmer.

- Volunteers staffed a Fairtrade tasting stall at Morrisons supermarket over two Saturdays, on 29th February and 7th March, promoting Fairtrade products stocked in store.

- Fairtrade Service held on 1 March 2020 at Hope Church in Cadoxton (formerly Cadoxton Methodist Church). Jenipher also attended this event

- Published an article in local newspaper “The Herald” (50+ Magazine) promoting Fairtrade

- Promoted Pancake Day and the use of Fairtrade ingredients on social media

- Barry Town Utd Fairtrade Football Match – 22/02/2020 – handed out bananas to supporters, and included an article in the matchday magazine

- Fairtrade Fortnight was covered extensively in the Barry & District News local newspaper

2021

- Promoted Fairtrade Fortnight through social media with regular information bulletins

- Worked with other Vale of Glamorgan Fairtrade groups to organise and promote a local version of the ‘World Through My Eyes’ art competition for young people. There were fifty participants and the winners received extensive coverage in the Barry & District News.
